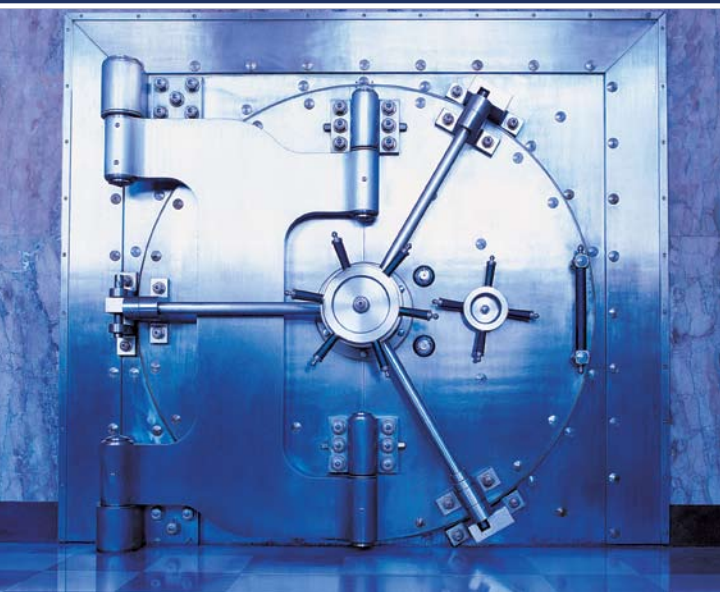

- Funds held in non-interest bearing transaction accounts are insured in full by the FDIC through June 30, 2010.
- Fund held in NOW accounts, which are interest bearing transaction accounts earning 0.50% or less, and Interest on Lawyer's Trust Account (IOLTA) accounts are also insured in full by the FDIC through June 30, 2010.
- On October 3, 2008, the FDIC increased insurance through January 1, 2014 for funds held in interest bearing accounts from \$100,000 to \$250,000 per depositor per category of legal ownership.
